

MEAL PLAN CONTRACT TERMS AND CONDITIONS ACADEMIC YEAR 2024-2025

A. ELIGIBILITY Unless one of the contract termination conditions apply. (See section J below) The first and last meal determined jointly between the Office of Residence Life and Dining Services. Dining Dollars will carry forward between Fall and Spring semester with the purchase of a Spring Meal Plan. You must purchase a Spring Meal Plan for remaining Fall Dining Dollars to roll over to the Spring semester. Any of your Dining Dollars remaining after the end of Spring semester will be forfeited. Meal Swipes are per semester and do not carry forward.

C. CLOSED SERVICE DAYS: Breakfast, Lunch, Dinner, and宵夜. Meal Plan is available during these times. Breakfast: 7:00 AM - 10:00 AM, Lunch: 11:30 AM - 2:00 PM, Dinner: 5:00 PM - 10:00 PM, 宵夜: 10:00 PM - 1:00 AM.

D. MEAL PLAN LIMITS: Meal Plan is for personal use only. It cannot be sold, transferred, or assigned. There is a maximum of 10 meal swipes per semester. Meal swipes are valid for one meal per day. Meal swipes are not valid for alcohol, tobacco, or other prohibited items. Meal swipes are not valid for off-campus dining. Meal swipes are not valid for special events or fundraisers. Meal swipes are not valid for dining in the residence halls.

E. TOBACCO FREE CAMPUS: In accordance with the University's tobacco-free policy, the use of tobacco products is prohibited on campus.

F. LIABILITY: The University is not liable for any injuries or damages resulting from the use of meal swipes.

G. STUDENT RESPONSIBILITY: Students are responsible for the proper use of meal swipes. Students must have a valid meal plan to use meal swipes. Students must use meal swipes at participating dining locations. Students must use meal swipes within the designated meal plan period.

H. RIGHT TO INSPECTION: Dining Services reserves the right to inspect meal swipes and meal plan usage.

I. CHANGING MEAL PLANS: Students may change their meal plan during the semester. Changes to meal plans will be processed by Dining Services. There may be a fee associated with changing meal plans. Changes to meal plans must be made before the end of the semester.

J. CONTRACT TERMINATION: Dining Services reserves the right to terminate the meal plan contract if a student violates the terms and conditions of the contract.
